Upon motion duly made, seconded and carried unanimously, it was: RESOLVED, that the board approves spending no more than \$1,000 for Los Primos to remove arborvitae and holly near baby pool and trim the trees around the flagpole.

Upon motion duly made, seconded and carried unanimously, it was: RESOLVED, that the board approves spending no more than \$4,500 for Sharp Lawn to replace ten maple trees at 2.5" caliper.

Upon motion duly made, seconded and carried unanimously, it was: RESOLVED, that the board approves spending no more than \$4,500 for Sharp Lawn to replace the holly bushes and green emerald arborvitae near the baby pool.

- Clubhouse Painting/Bathrooms Painters are working now and will complete work soon and will paint bathrooms next. Mr. Yates will ask them to paint the columns as well.
- **Railing** Project will be completed this week. Board will take a look and update Mr. Yates regarding color (brown versus black).

- 4. Pool
 - Pump The pump broke recently, but no one reported it. Mr. Yates said that there needed to be more communication regarding the issue, he spoke to the pool company and they understand.
 - Filters The board discussed the possibility of purchasing back-up filters. Mr. Yates will discuss with the pool company.
 - Pool Cover The board asked Mr. Yates to get a price for a pool cover.
 - Pool Rules There have been some folks swimming under the diving board and Mr. Fain will address with the guard staff.
 - Balls in the Pool The board discussed type of balls allowed in the pool. Nerf balls were initially allowed, but there have been other types as well. The concern is the safety and enjoyment for other patrons of the pool.
 - Basketball Goal The board discussed the possibility of bringing the goal back.
